Minutes of the meeting of IQAC

It was decided unanimously that the concessions will be revised for the academic session 2023-24 as follows

- 1. Merit Concessions: (for Ist semester only)
 - 15% of college dues for students above 87% to 92% in 12th standard.
 - 25% of college dues for students above 92% to 95% in 12th standard.
 - 50% of college dues for students above 95% to 98% in 12th standard.
 - 100% of college dues for students securing 98 % or above in 12th standard.
- 2. A concession of Rs. 2500/- will be given to a student (in 2nd semester) every year who is parentless.
 - A concession of Rs. 2000/- will be given to a student (in 2nd semester) every year who is fatherless/motherless.
- 3. Sibling concession of Rs. 1000/- will be given to younger one (in 2nd semester) every year.



- 4. Freedom Fighter Concession- A concession of Rs. 2500/- will be given to the student (upto grandchildren of freedom fighter only) (in 2nd semester) every year.
- 5. Divyangjan Concession- A concession of Rs. 3000/- will be given to physically challenged students (percentage disability should be more than 40%) (in 2nd semester) every year.

6. Sports Concession-

- For a state level player/athlete-50% of college dues. (Position holder)
- For a national level player/athlete-75% of college dues.(Position holder)
- For an International level player/athlete 100% of college dues for participation only.
